1. WELCOME AND APOLOGIES

Clare Kershaw, Director for Education, welcomed everyone to the meeting.

2. MATTERS ARISING FROM THE EPHA EXECUTIVE MEETING EARLIER

a) Change of date for Executive meeting in the summer term

It was confirmed that the date of the summer term EPHA Executive meeting will be changed to Wednesday 24th May 2023 as the venue cannot accommodate the original date.

b) SEND workforce and operational issues

The EPHA Chair noted that a number of Inclusion Partners had taken leave during September, which is a key time for schools who need to access their support. This was noted by CK.

c) DSL supervision project

This has been well received by those who were selected for the pilot.

d) Home-school transport

Matt O'Grady raised once again his concerns about home to school transport, particularly for those children with additional needs. He accepted that the responsibility for this does not lie with the education team, but asked who schools should contact if they have concerns. He also asked if guidance could be produced for families so that they understand the service better, including recognising that it is not managed or run by schools. CK noted that if schools have concerns they should contact the Passenger Transport inbox.

e) EPHA annual general meeting

Harriet Phelps-Knights noted that she has been elected to continue as Chair of EPHA for another year, and that Nick Hutchings will continue as Vice-Chair, following the annual general meeting earlier in the day.

3. UPDATE FROM THE DIRECTOR OF EDUCATION

Clare Kershaw noted that she had deliberately kept her communication at the

beginning of term as optimistic as possible, given the challenging times that schools are facing. She expressed her hope that with Covid receding as a problem, the term might be less disrupted, but acknowledged the many stressors on schools and headteachers, including the impact of the pandemic on mental health and wellbeing and pupil outcomes – and the challenges faced by schools, particular in respect of funding.

a) Financial pressures in schools

CK noted that the energy price rises are all-consuming and are causing a great deal of worry for school leaders. There is no additional funding available from the Local Authority, but CK is hoping that the Government will recognise the serious of the situation for schools, noting that it is likely that all schools will be financially unviable in a year or two if sustainable funding solutions are not offered. CK has been meeting with ECC procurement and finance and has asked schools to provide information about their existing and/or new contracts, as it is helpful to understand the picture across the county.

CK recognised that schools set their budgets when the impact of staff pay awards energy price rises weren't known. She noted that schools are likely to be required to use their reserves to cover rising costs, but accepted that this will create issues later on, when schools are unable to pay for intended developments and improvements. There are reserves in schools across the county, but they are spread unequally. CK argued that maintained schools will run out of funding sooner rather than later which will be a mater for the LA, but that the ESFA will also have to oversee the financial shortfall in academies. Obviously the energy price cap will help for the next 6 months.

One headteacher noted that schools are unable to set deficit budgets, and asked CK to give some reassurance to governors, particularly as schools will soon enter the budget setting period. CK suggested waiting for the three month review promised by Government, but stressed that the Local Authority is lobbying the DfE around school funding.

b) Essex Education Taskforce

The Taskforce has focused on the Essex Year of Reading, as well as supporting the emotional wellbeing of headteachers. Steve Whitfield is focusing on guidance around physical activity and wellbeing and encouraging self-help strategies to improve wellbeing.

c) Partnership Strategy

The Partnership Strategy lead headteachers and LA officers met on 20th September and held a useful meeting to determine what support the system can continue to offer schools.

4. SEND STRATEGY

CK reminded the Executive that a letter had gone out earlier in the term outlining the SEND strategies that are being rolled out to support schools. SENDIASS has been expanded and there is ongoing whole system reform in relation to therapies.

The system is challenged by the high vacancy rate of Educational Psychologists, which

is a country-wide problem. CK explained two possible mitigations including an active recruitment campaign, and revising the use of the existing workforce, including redirecting the EP focus and using those with less experience but with relevant expertise.

There was a discussion about the time it takes to undertake a needs assessment for EHCPs; one headteacher has been asked by a parent for compensation as the process has exceeded 20 weeks. CK noted that in these situations parents should contact the LA, and agreed that communication to parents about the challenges in the system is important.

She noted that the Inclusion Framework should help support the system, by offering practical support solutions and some associated funding to schools, before the need to engage the statutory process. She accepted that schools that haven't yet been involved in the Inclusion Framework may not yet understand the benefits, and there will be continued feedback from schools that are using the system, at the termly headteacher meetings.

The SEND Sufficiency Plan, forecasting the prevalence of children and young people with SEND, is helpful but worrying. CK acknowledged that there are not enough places in Special Schools, and the special schools development in Essex has been hindered by the delay to the construction of free schools that are being funded by the DfE; ECC has delivered on its part of the capital programme, but the DfE funded projects are unlikely to be completed until September 2024 at the earliest.

It was **AGREED** that it would be helpful for CK to offer a webcast to explain the SEND structures and organisation to school leaders. *(The Professional Officer will contact Denise Hobbs to set this up.)* Schools should receive information about their SEND workforce links shortly.

CK noted that there is some surplus in the Essex High Needs Block (unlike that of some authorities) but that this needs to be spent carefully in order to enhance the system for the longer term. ECC is investing in increased capacity and workforce development; she accepted that there needs to be a focus on maintaining a functioning system while the improvement work starts to impact.

One headteacher noted that schools would welcome interim financial support whilst waiting for assessment decisions. IPRA funding is a finite amount of funding which can be particularly useful to the school.

The group discussed intelligence and work with pre-schools. AF noted that the Early Years Education Partners have regular contact with pre-schools, thought there is a variable quality of staff in the range of pre-school settings, and some are unwilling to have difficult conversations with parents. One headteacher noted that the Early Years cohort of children coming into her school has definitely been impacted by Covid and are presenting with exceptionally immature behaviour and development, particularly in relation to speech and expected life skills, including being toilet trained. She felt that an amount of (IPRA) funding could help support schools in this regard. CK stated she would consider how Reception staff could be supported.

Professional Officer

There was a suggestion that Health is putting up barriers to schools, such as not taking on ASDs. In addition, some health workers are suggesting that schools will offer counselling, rather this being offered by health.

4. SUSTAINABLE SCHOOLS DASHBOARD

Alison Fiala explained that a revised version of the Sustainable Schools Dashboard has been developed and will be made available to schools, supported by their School Effectiveness Partners. Various data has been added to the dashboard, including deprivation, PPG and updated census information. The LA is keen to be proactive with maintained schools to help support them, and the dashboard is available to academies who wish to use it.

5. SAFEGUARDING UPDATE

Jo Barclay, Head of Education Safeguarding and Wellbeing, gave the following updates:

a) Updated materials, model policies and presentations are available on the safeguarding page of the Essex Schools Infolink.

https://schools.essex.gov.uk/pupils/Safeguarding/Pages/Safeguarding.aspx Presentations include updates on the Ofsted inspection safeguarding expectations, and governor training.

b) Schools Safeguarding Audit

An updated version should be available by half term, and will be required to be submitted by the end of the spring term.

c) Early Years and Pre-school safeguarding

There has been a focus on early years safeguarding and JB reported that they are starting to see strengthened practice, specifically around child protection file transfer. She asked headteachers to contact her if they have any issues in this regard.

d) Year 6 – 7 transition

JB asked headteachers to consider their particularly vulnerable children in Year 6 and to work with parents during the school year to ensure that they apply for a secondary school place for their child.

e) Harmful Sexual Behaviour model policies

In response to requests from primary schools, we have provided a separate model policy on harmful sexual behaviour. This new policy plus an updated version for secondary settings is available on <u>ESI</u>

Schools will have the opportunity to undertake the NSPCC training on harmful sexual behaviour, with a funded licence for a member of staff in each school.

 f) Training opportunity: 'Information Sharing – understanding the statutory requirements in relation to safeguarding'

To support schools and settings to understand the statutory requirements around Information Sharing and Data Protection in relation to safeguarding, we are pleased to offer a training session in conjunction with the ECC Information Governance Team. The session aim is to increase the knowledge, understanding and confidence of schools and settings when sharing information in relation to safeguarding work. The session is open to Headteachers, Designated Safeguarding Leads, Deputy Designated Safeguarding Leads and Data Protection Officers within ECC schools and settings. There are 2 dates available, but you only need to attend one session. The dates are:

- Monday 28th November 2 pm 4.30 pm
- Tuesday 7th February 9.30 am 12 pm

g) Effective Support for Children and Families in Essex

Working Together requires the Essex Statutory Partners (Essex County Council, Police and Integrated Care Boards) to publish a threshold document. In Essex, this is the Effective Support guidance.

The Statutory Partners have nominated a multi-agency working group to review the current guidance and consider how children and families can be supported across all levels of need, to ensure they receive the right help at the right time.

To ensure those using the guidance have an opportunity to shape the updated document, the ESCB is asking practitioners to <u>complete a survey</u> – the closing date is the 26th September. Please be honest in your feedback, as it's important this is an effective working document.

h) SET Domestic Abuse Board

TONIC (<u>www.tonic.org.uk</u>) have been asked by the SET Domestic Abuse Board (SETDAB) to help gain a deeper understanding of the experiences of people who have been affected by domestic abuse, and to use these findings to help shape the design of a whole system response to domestic abuse. The project has a discovery (fieldwork) and a design (co-production) phase. We would really value your help in promoting opportunities for people to engage in both phases of the project and have their voices heard.

i) Learning from Child Safeguarding Practice Reviews (CSPRs)

We routinely bring the learning from CSPRs into the materials and resources that we produce and also share it at the safeguarding forums.

In order for the learning to be shared across the wider partnership, the Essex Safeguarding Children Board have decided to produce a range of themed resources under the banner of Working Together Better.

The first topic identified from recent reviews in Essex is the <u>voice of the child</u> and the resources related to this are available on the ESCB website. You may use these resources to support your level 2 training for all staff, and it is important for each setting

to think about how the learning is reflected in practice within their own setting.

j) The Affinity Programme – children at risk of exclusion due to emotional dysregulation

The Affinity Programme supports children and young people who are at risk of exclusion from education due to emotional dysregulation. The Affinity Programme's team of practitioners and emotion coaches work with both schools and families to bring together a Trauma Informed Affinity Partnership.
