Preparing for the General Data Protection Regulation

Many of you will have picked up information about the impending change to the Data Protection framework; in brief, the Data Protection Act 1998 (DPA) will be replaced on 25th May 2018 with the new General Data Protection Regulation 2016 (GDPR). This introduces far more stringent requirements for Data Controllers, which includes all schools.

Lauri Almond, Business Consultant for ECC Information Governance Operations, will attend the four summer term headteacher meetings in June to ensure that heads are aware of the duty and have started to put arrangements in place to meet their responsibilities. EPHA will also be organising more detailed training across the county, and we will let you know where and when that will take place. In the meantime, download the ICO 12 steps document from the EPHA website to start raising your awareness of the new regulations.
