As you are well aware, the Data Protection Act 1998 (DPA) will be replaced on 25th May 2018 with the new General Data Protection Regulation 2016 (GDPR).

There has been a wealth of information about the changes (some helpful, some less so!) and EPHA has created a new page on the website where you will find checklists, model policies, privacy notices, training tools, guidance and information about data protection and GDPR.
