Introduction

Poor school attendance is most often a symptom of a myriad of other factors and can be an indicator of a child or young person either becoming at risk of, or already affected by, a number of issues such as:

- CSE (Child Sexual Exploitation)
- Substance misuse
- Gang affiliation
- Radicalisation
- Domestic violence
- Being a Young Carer without support
- Truancy
- Anti-social behaviour
- Bullying
- Child abuse
- Underachievement
- Becoming NEET (Not in Employment. Education or Training)

OFSTED

School attendance and persistent absence INTERVENT **remain a focus for OFSTED**, not just in terms of considering 'performance information presented by the school for current pupils across year groups and previous cohorts' but also 'including that provided by external organisations'. They will also 'consider the published data available to them before the inspection.' (OFSTED handbook, 2015).

Monitoring attendance and intervening when needed is a **key safeguarding duty** held by all schools. OFSTED highlight that they will be looking for schools to demonstrate that:

"Children who go missing from the setting they attend receive well-coordinated responses that reduce the harm or risk of harm to them. Risks are well understood and their impact is minimised. Staff are aware of, and implement in full, local procedures for children who are missing from home and/or from education."

and:

"Appropriate action is taken when children and learners stop attending the setting or do not attend regularly"

Attendance Support Packages



Detailed below are examples of the support and intervention packages we can offer. This directory is not exhaustive. Package	Details
Comprehensive Support Package	 School Consultations – Identifying cases where attendance is causing concern. Discussing suitable cases for case work, Early Intervention clinics, advice and guidance on signposting for additional support. Advice on use of "DFE absence codes". Attending 'Early Intervention Clinics' – Supporting school led meetings with Parents and/or students. Reception Clinics – Support parents to embed good practice from an early age to prevent attendance concerns arising once the child becomes statutory school age. Coffee Mornings – Attend Coffee Mornings arranged by school, to address particular cohorts of parents whereby attendance is of concern i.e. Families where English is an additional language, Reception parents etc. Leading Assemblies for students, raising the profile of attendance in school. Attending Parent Evenings / Open Evenings. OFSTED Support – Supporting your school with report writing for OFSTED. Attending school during OFSTED visits to support school staff. Data Analysis – Using existing school systems to identify and track pupils' attendance. Focusing on vulnerable groups i.e. SEND, Ethnicity, FSM, PP, LAC. Writing Attendance Policies. Home Visits – Support school staff in attending home visits for pupils who may be missing from education and/or there are safeguarding concerns. Support in adhering to the Local Authorities' code of conduct for issuing Penalty Notices.
Supervision	We can offer your dedicated Attendance Officer(s) and/or SLT supervision, advice and guidance on progressing cases, assistance with completing referrals to support agencies, etc.
Training	 Coding Absences & Seeking Evidence. Effectively Using Data to Identify and Target Individuals or Groups. Attendance: A Whole School Approach. Training New School-Based Attendance Staff. Court Process and Being a Witness in Court.
Audit	 Attendance Health Checks/Audits – "Deep Dive" into attendance data to scrutinise use of codes, studying patterns of absence, both authorised and unauthorised. Intensive analysis and report of findings provided to school and action plan completed.

Tracker creation and license

- Create an excel tracker that allows staff to populate on a weekly basis with the
 attendance records of some / all students and shows RAG rating of attendance
 against the previous week and against the overall school target. The tracker will
 be purchased on a license period for two school years initially.
- Included in the license cost is an initial consultation to establish functionality needs, two hours of initial staff training and additional email support to agreed SLA standards for the duration of the license period.

Analysis of data

Data Analysis Service

- Reports / analysis of attendance data created and explained to schools in face to face meetings
- Reports / analysis of wider school data e.g. exam grades, behaviour (if recorded)
- **Analysis and statistical testing** for links between data sets e.g. to what extent does attendance relate to exam grades.
- Analysis of cohorts e.g. free school meals, those living in highest deprivation areas, BAME, SEN to help inform and influence policies and interventions (such as where best to target attendance officers, emotional / behavioural support) by producing and presenting a needs analysis of school pupils.

Infographic and visual presentations

- Creation of infographics for publications e.g. in promotional materials, prospectuses
- Visualisation of data in graph form.
